2. The Licensee is obliged to send **copy(copies)** of the aforementioned publication to the University of Warsaw Library⁵.
3. These Conditions together with the Licence Confirmation constitute the licence agreement between the the University of Warsaw Library and the person or institution identified in the Licence Confirmation as the Licensee. All licences and permissions in the Agreement are conditional. Reproducing any photographs or other copyright work(s) in breach of or outside the scope of the Agreement is an infringement of the copyright.
4. A single use means a reproduction in a single Licensed Product. The Licensee shall use the Image only in the Licensed Products and not on any other products or in relation to any other service. Licensed Products must not be of any other type than those described in the Licence Confirmation. Except for the rights granted to Licensee in this agreement, no other rights in and to the Images are granted.
5. All amounts quoted in the Licence Confirmation and any invoice should be paid by the Licensee to the University of Warsaw Library within 14 days.
